## Current Emissions Reporting

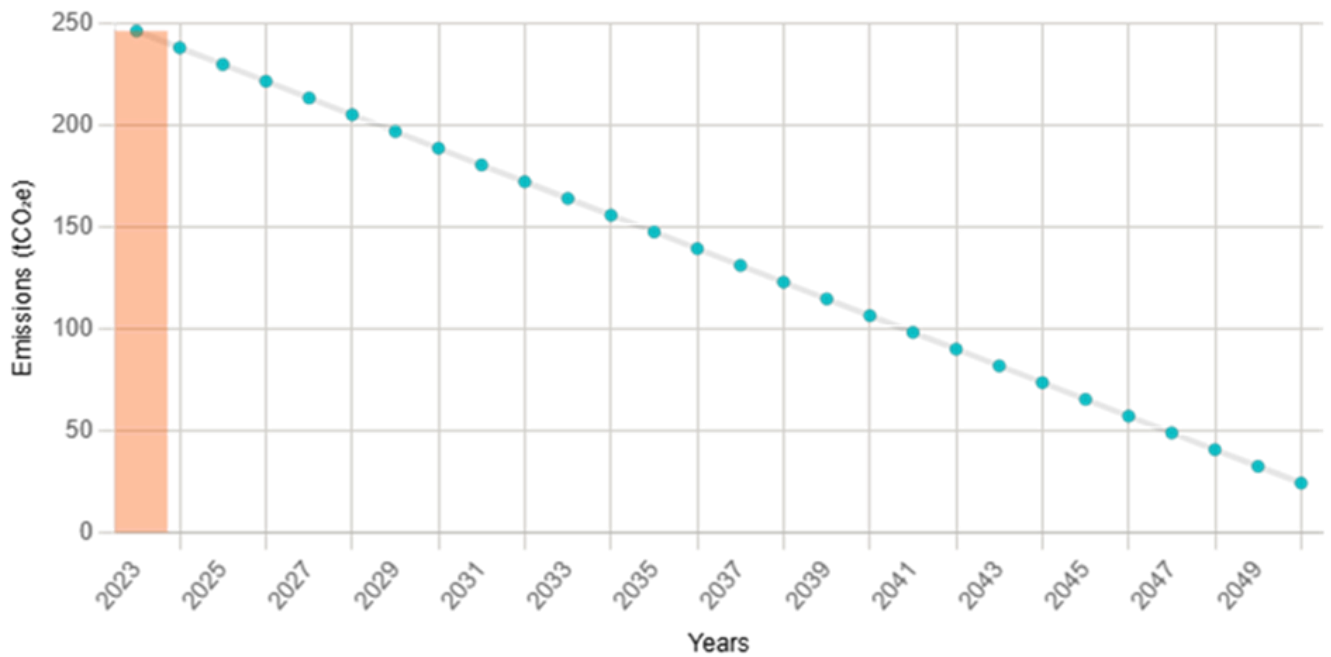
As this is the first reporting year, no further emissions can be reported at this time.

## Emissions Reduction Targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease to 190.12 tCO<sub>2</sub>e by 2029. This is a reduction of 25.20%.

## Carbon Reduction Projects

In the future we hope to implement further measures such as:

- 1. Office relocation - this will downsize from the current office and significantly reduce Scope 1 and 2 emissions and will be carried out within the next 12 months.*
- 2. Behavioural change campaign - This will create more sustainable and efficient behaviours amongst staff to achieve a reduction in Scope 1, 2 & 3 emissions. This will be implemented within the next 18 months.*
